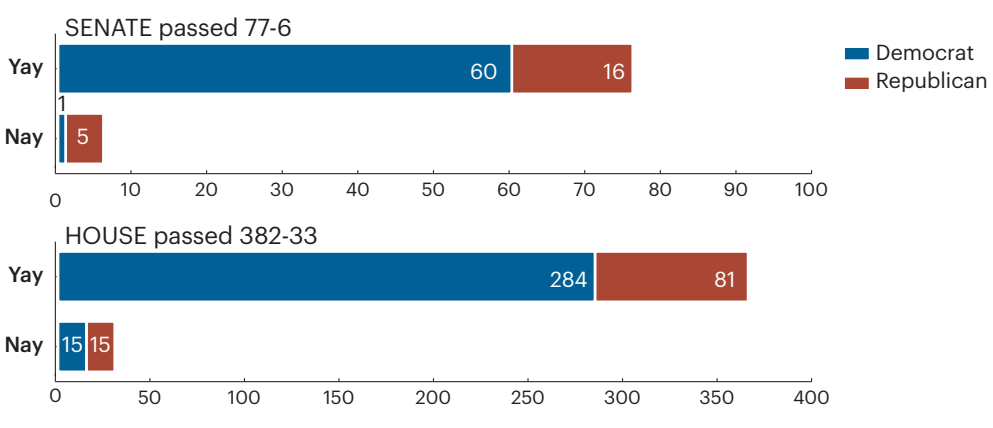


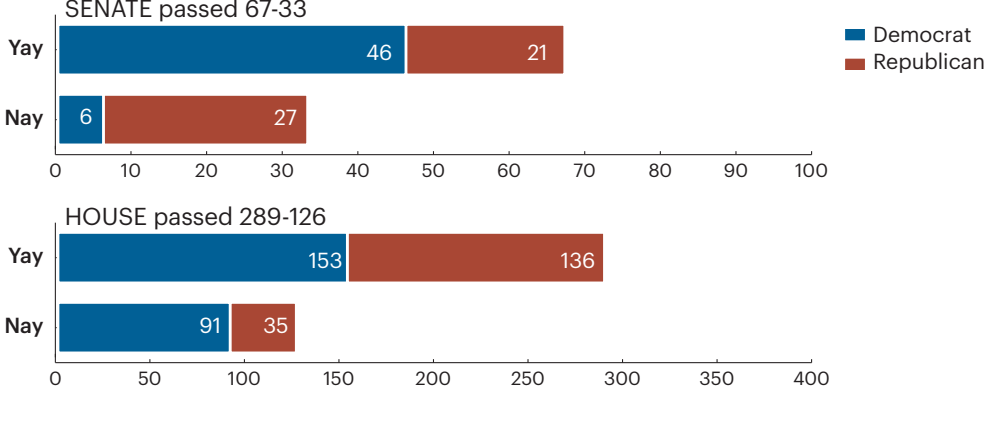
Key Votes Since 1935 Charting Bipartisanship And Its Demise

Pre “Contract with America” – Landmark legislation that makes significant contributions to the lives of Americans receives bipartisan support:

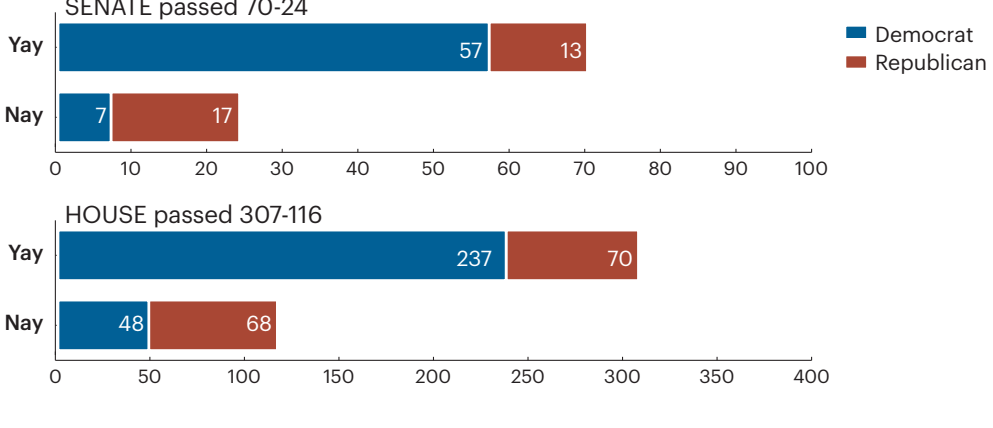
Social Security Act (1935): Perhaps the most effective bill to come out of the New Deal. Provided an important safety net for the elderly, poor, unemployed and young.



Civil Rights Act (1964): One of the most significant pieces of legislation in our country’s history prohibited racial discrimination in public facilities, government, and employment.

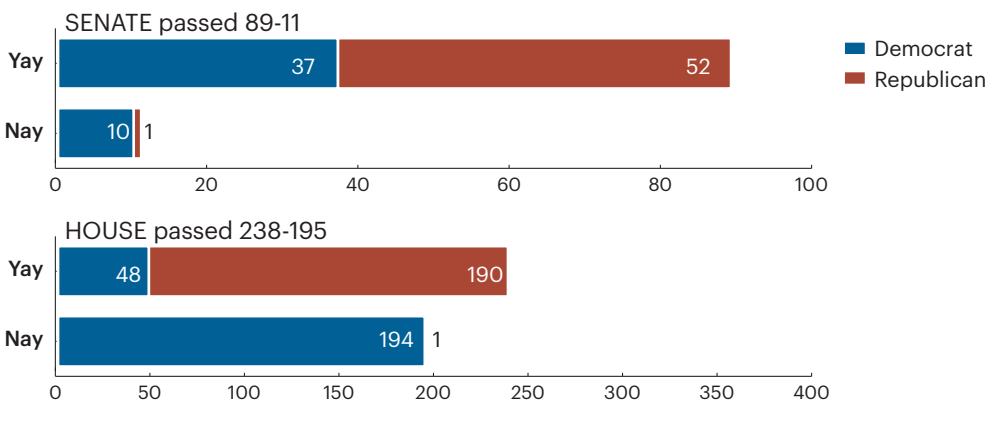


Medicare and Medicaid (1965): This controversial legislation provided health insurance for those over 65 and for poor families.

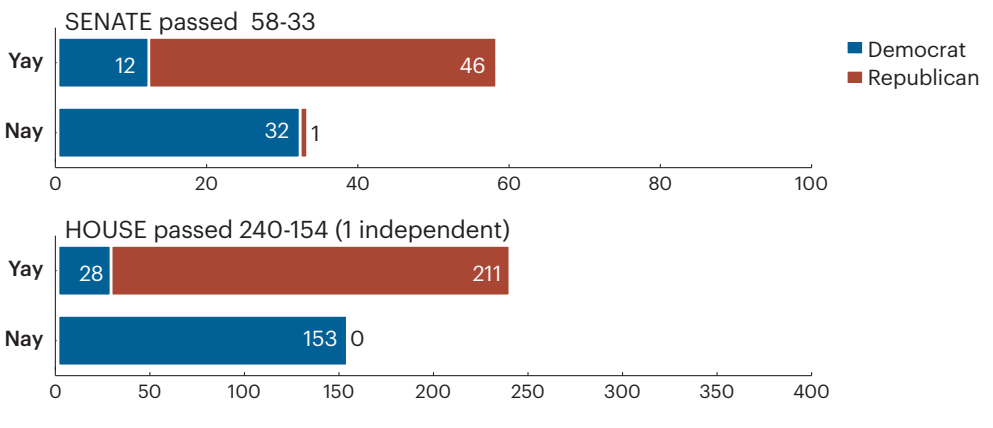


Post “Contract With America”- Major legislation passes without bipartisan support, aside from the “Reagan Democrats.”

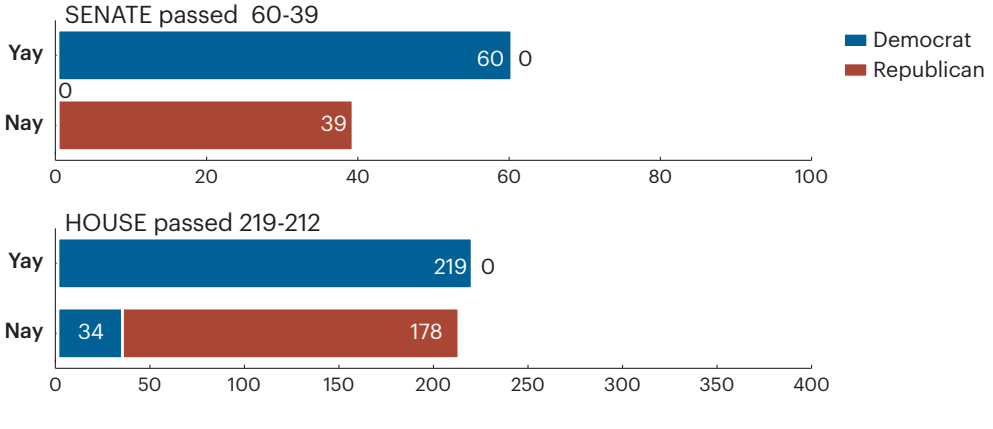
Economic Recovery Tax Cut (1981): The bill, also known as the 1981 Reagan Tax Cuts, reduced marginal income tax rates to provide incentives for small businesses and saving. Many Democrats who voted for the measure were referred to as “Reagan Democrats.”



Economic Growth and Tax Relief Reconciliation Act (2001): Also known as the Bush Tax Cuts, the bill outlined a 10 year, 1.35 trillion tax cut.



Health Care Reform (2010): The sweeping health care reform bill expanded Medicaid eligibility, gave incentives for small businesses to provide healthcare, and provided money for medical research.



Wall Street Reform and Consumer Protection Act (2010): This massive piece was the largest change to financial regulation since the Great Depression.

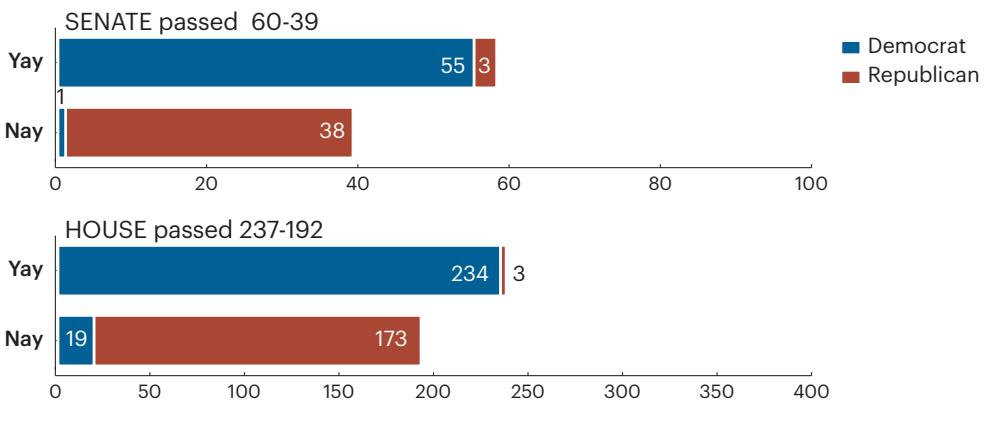
